 02. Manufacturers/ The Dealer should have VAT Registration number and PAN CARD.(Attach copy)
 03. Manufacturers/ The Dealer should have a well established Office and distribution set up in Bihar and should have been dealing with supply of Note counting machine and fake note detecting machine atleast for the last two years.
 04. The Manufacturing company must warrant all equipments, accessories spare parts etc. against any manufacturing defects during the warranty period, Company shall maintain the equipment and repair/replace at the installed site all defective component , at no charge to Uttar Bihar Gramin Bank .
 05. The Bidder shall furnish copies of Dealership issued by the manufacturer. (If the bidder is Dealer of a Company)
 06. The Bidder shall furnish copy of Bihar Sales and Service Tax Registration
 07. Model of Note Counting Machine : FLOOR MODEL/ DESK MODEL
 08. The quotation must include on site warranty covering replacement of all parts with labour cost for a minimum period of two years .Warranty period will start after the complete installation of the equipment .
 09. The quotation must include Annual Maintenance Charges(AMC)
 10. The quotation must be with commitment to provide maintenance after the date of expiry of warranty period .
 11. The price shall be inclusive of all taxes.
- Payment terms** :: 90% of order value will be paid by Head Office on completion of installation and 10% amount will be paid after 06 months of satisfactory performance.
